- (1) The Vendor does not undertake and is under no obligation to review, consider or accept the highest offer or any offer at all for the purchase of any specified residential property. The Vendor has the absolute right to withdraw from the sale of any specified residential property at any time before the acceptance of any offer. The Vendor has the absolute right to accept any offer at or before the closing time of the tender. 賣方並不承諾亦無責任閱覽、考慮或接受認購任何指明住宅物業最高出價之要約或任何要約。賣方有全權於接受任何要約前於任何時間撤回出售任何指明住宅物業。賣方有絕對權利於招標截止時間或之前接受任何要約。
- (2) Persons interested in submitting tenders of the specified residential properties are reminded to read the latest register of transactions of the Development so as to ascertain whether a particular specified residential property is still available for tender

on a date of sale. Although a specified residential property may be available for tender on a date of sale, it may become unavailable during that date of sale because the Vendor may accept a tender within the acceptance period after the close of a previous tender exercise. In such event, the Vendor will reject offer(s) for purchase of the residential property. Please also note that the register of transactions of the Development may not be updated immediately after the Vendor accepts a tender.

有意遞交指明住宅物業的投標書的人士敬請檢視發展項目最近的成交紀錄冊，以知悉某一指明住宅物業在某一出售日期是否仍然可供出售。雖然某一指明住宅物業可能在某一出售日期仍然可供出售，因賣方可能會在先前的招標程序完結後的承約期間內接納該指明住宅物業的投標書，該指明住宅物業可能於該出售日期內的期間變為不再可供出售。在此情況下，賣方將拒絕接受該物業之其他要約。另請注意，發展項目的成交紀錄冊在賣方接納該物業的投標書後未必能即時更新。

- (3) The Vendor reserves the right to adjust the closing date and/or time of the tender from time to time by amending the Information on Sales Arrangements in relation thereto. The Vendor is not obliged to separately notify the tenderers of such adjustment.

- (4) The Vendor reserves the right, in its absolute discretion, to disqualify any tenderer who submits any non-conforming tenders or who does not submit a valid or properly executed document according to the tender document.

- (5) In case a black rainstorm warning signal is issued or a typhoon signal no.8 or above is hoisted by the Hong Kong Observatory or an announcement on “extreme conditions”

is made by the Government of Hong Kong and is still in effect after 4:00 p.m. on the tender closing date, the closing date and time of the tender will be extended to 5:00 p.m. on the next working day in respect of which no black rainstorm warning signal is issued or no typhoon signal no.8 or above is hoisted by the Hong Kong Observatory or no announcement on “extreme conditions” is made by the Government of Hong Kong.

若在招標截止日期下午 4 時正後香港天文台發出黑色暴雨警告或八號或以上颱風信號或香港政府發出「極端情況」公布及該警告或信號或公布仍然生效，截標日期及時間將延至下一工作日的下午 5 時（而當天亦沒有黑色暴雨警告或八號或以上颱風信號發出或沒有「極端情況」公布發出）。

- (6) The Vendor may from time to time impose health and security related precautionary measures and crowd control at the Sales Office. Any person who fails to comply with such measures and the direction of the Vendor may be rejected from admitting to the Sales Office.
